#### INFORMATION TO BIDDERS

Each bid must be submitted in a sealed envelope, addressed to the Board of County Commissioners and clearly marked, **BULK CHEMICALS.** 

Each bidder is responsible for reading and being thoroughly familiar with the specifications. Failure or omission of any bidder to do any of the foregoing shall in no way relieve any bidder from obligation with respect to his bid. A CONDITIONAL OR QUALIFIED BID WILL NOT BE ACCEPTED.

All bids must be submitted on the required bid form, either in ink or typewritten and the bid form must be fully completed and executed when submitted.

The bulk chemicals will be delivered to any of the following sites:

Each bid must be accompanied by a bid bond, payable to the owners, County of Medina, for 5% of the total amount of the bid. As soon as the bid prices have been compared, the OWNER will return the bonds to all, except the lowest and most responsible bidder(s). The bid bond of the successful bidder(s) will be retained until a performance bond has been executed and approved, after which it will be returned. A certified check may be submitted in the amount of \$100.00 per chemical bid in lieu of a bid bond.

The performance bond, in the amount of 10% of the contract price, with a corporate surety approved by the owner, will be required for the faithful performance of the contract requirements.

Attorneys-in-fact, who sign bid bonds and performance bonds must file with each bond, a certified and effective dated copy of their power of attorney.

All bid prices shall include shipping and/or freight costs and will be effective for one (1) year beginning December 15, 2018 and ending on December 14, 2019. The Board of County Commissioners shall have the option of renewing the Bulk Chemicals contract for one (1) additional one (1) year term if so agreed by both the County and the Supplier, by mailing written notice to the Supplier of its determination to renew on or before **October 15, 2019**.

The Board of County Commissioners reserve the right to reject or accept any or all bids if evidence submitted by or investigation of, such bidder(s) fails to carry out the obligations of the agreement and to complete the work contemplated therein.

### SPECIFICATIONS FOR LIQUID CHLORINE

- 1. Shall be commercially available in the form of liquified elemental chlorine gas.
- 2. Shall be 99.5% pure by volume, as obtained from vaporized liquid chlorine and shall be suitable for use at Water and Wastewater Treatment Facilities.
- 3. Shall be free from excessive concentration of impurities such as Bromine, Nitrogen Tetroxide, Silicon, Tetra Chloride and Sulphuric Acid.
- 4. Shipping containers shall conform with regulations of the Interstate Commerce Commission. Containers shall be new or reconditioned, maintained and loaded in strict accordance with the latest edition of "Container Procedures at Chlorine Packaging Plants", issued by the Chlorine Institute, Inc. Delivery to facilities shall be in open top trucks or semi-trailers for unloading purposes. When delivered, must meet specific codes of Industrial Commission, Division of Safety and Hygiene of the State of Ohio.
- 5. Shall conform in all respects with the AWWA Standard #B301-59 for liquid chlorine as issued in the American Waterworks Association.
- 6. Delivery guarantee will be within 72 hours of placing the order, to the facility placing the order. All deliveries shall be scheduled between 9:00am 11:30am or 1:00pm 3:30pm. NO WEEKEND DELIVERIES ACCEPTED. Semi-trucks not permitted at water facilities. Minimum two (2) hour notification prior to delivery must be given to the MCSE Administrative Office.
- 7. Empty Chlorine Cylinders must be picked up within 72 hours of request.
- 8. Minimum orders will be placed and will include at least four (4) 150 lb. Cylinders <u>and/or</u> a minimum of one (1) ton cylinders per delivery.
- 9. Estimated annual purchase is one hundred ten (110) one (1) ton cylinders and one hundred (100) 150 lb. cylinders.
- 10. Bid shall include annual chlorine handling training by the supplier.
- 11. All bid prices submitted shall include shipping and/or freight costs. Contract Award shall be for a one (1) year period commencing on December 15, 2018 with the option to renew for one (1) additional year.

#### SPECIFICATIONS FOR SODIUM HYPOCHLORITE

- 1. Shall be commercially available in liquid form, having a 12% to 16% available chlorine packaged in five (5) gallon containers or 2.5 gallon containers, and suitable for use at water treatment facilities.
- 2. Shipping containers shall conform with regulations of the Interstate Commerce Commission. Containers shall be new or reconditioned, maintained and loaded in strict accordance with the latest edition of "Container Procedures at Chlorine Packaging Plants", issued by the Chlorine Institute, Inc. Delivery to facilities shall be in open top trucks or semi-trailers for unloading purposes. When delivered, must meet specific codes of the Industrial Commission, Division of Safety and Hygiene of the State of Ohio.
- 3. Shall conform in all respects with the AWWA Standard #B300-99 for Hypochlorites as issued in the American Waterworks Association.
  - The Sodium Hypochlorite solution (NaOCI) provided under this contract shall be a clear light-yellow liquid containing up to 160 g/L (16 trade percent), but not less than 100 g/L (10 trade percent) available chlorine, and not more than 0.15% insoluble matter by weight. This material should be certified and clearly labeled as suitable for contact with or treatment of drinking water by an accredited certification organization in accordance with ANSI/NSF Standard 60, Drinking Water Treatment Chemicals-Health Effects.
- 4. All deliveries shall be scheduled between 9:00am 11:30am or 1:00pm 3:30pm. NO WEEKEND DELIVERIES ACCEPTED. If delivery cannot be made by 3:30pm, delivery will have to be made the next day. **DO NOT LEAVE SODIUM HYPOCHLORITE OUTSIDE AFTER HOURS.** Semi-trucks not permitted at water facilities. Minimum two (2) hour notification prior to delivery must be given to the MCSE Administrative Office.
- 5. MINIMUM ORDERS WILL INCLUDE AT LEAST 30 FIVE (5) GALLON CONTAINERS OR AT LEAST 60 2.5 GALLON CONTAINERS.
- 6. Estimated annual purchase is three hundred (300) five (5) gallon containers or six hundred (600) 2.5 gallon containers.
- 7. Delivery guarantee will be within 72 hours of placing the order, to the facility placing the order.
- 8. All bid prices submitted shall include shipping and/or freight costs. Contract award shall be for a one (1) year period commencing on December 15, 2018 with the option to renew for one (1) additional year.
